Overthrows and lanterns

Please see below a letter from our Chairman regarding a fantastic initiative to enable local owners to reinstate the overthrows and lanterns which were originally part of the front railings.

PERA wishes to file a "blanket" application for the reinstatement of overthrows and lanterns for all the houses on the above streets. The current planning reference 08/04673/FUL is only for some properties, and we wish to extend this to cover all houses so that owners who wish to reinstate an overthrow of the design approved by Listed Buildings will not have the expense of filing individual applications

This involves you in no cost or obligation, but merely notifies you of our intention, so that in the future you or subsequent owners may install a lantern and overthrow of the design approved in ref 08/04673/FUL. This design is as close as possible to that of the Georgian original that probably once graced your home.

To date ten new overthrows and lanterns have been reinstated in our neighbourhood, and we hope that other residents will consider installing them, further enhancing the streetscape for current and future generations of owners and visitors. Bath Rugby

Regardless of your stance on Bath Rugby developing the Recreation Ground or not, PERA is trying to keep residents informed of the emerging developments.

Recent consultation events have taken place regarding Bath Rugby's future plans to develop their facilities at the Recreation Ground. The Club's land use and Stadium plans (as they develop) are available online at **www.bathrugby.com**.

We understand that there will be a community wide exhibition in the coming weeks they will then proceed with designs for a planning application this Spring.

In summary Bath Rugby are now seeking to redevelop permanent improved stadium facilities within the existing footprint of the current stadium, but with an extension to the seasonal East stand still being removed three months of the year. The plans do though show that the temporary East stand will move back by circa 10m and currently at this stage of the design evolution it has a roof which PERA believe is inappropriate as the height more than doubles from 8.2m to 19.15m at its highest point. By way of reference the current floodlights are 17m high. The proposed North Stand at the end of Johnston Street will be between 2.1m and 3.6m above the street level.

They have also confirmed that with this plan there will be no expansion of "commercial" activities at the facility. The CEO of Bath Rugby has stated that the plans for the improved facilities under the West stand will only include a café/bistro and ticket office, generally facilities only open late on match days. However they have consistently refused to give any assurances on closure times - our concerns are late night bar venues along this river side and the consequent impact of anti-social behaviour into the heart of this residential area.

PERA's position has always been the safeguarding of the Recreation Ground as a place for all sporting clubs and groups, who are good neighbours to local residents. We therefore require more information about the safeguarding of the other sporting activities on the Rec. We will also wait to see detailed design, the Heads of Terms lease, and the judgment from the Charity Commission Tribunal which is due in March, before taking a final position.

Areas that we have been involved in this year include working with the Bath Marathon organisers to minimise disruption locally (2013 was probably the best so far in this respect); liaising closely with Bath Rugby on matches so that noise and traffic issues are minimised (we have a very good operational relationship); liaising and lobbying the Council on coach parking issues in Laura Place in connection with the Christmas market (coaches were banned from using Laura Place); liaising with bus companies on frequency and timings of buses; lobbying the Council on planning issues that adversely impact local people; liaising with and lobbying the Council on issues around anti social behaviour and begging; liaising with and lobbying the Council on alcohol licensing; liaising with and lobbying the Council and BID on street cleanliness/recycling/ gulls as well as a variety of issues in both Sydney Gardens and Henrietta Park.

PACT

Many attendees at the city centre PACT meetings last Summer reported a surge in "organised" begging across the city centre. In addition there was an increase in dog attacks from the street drinking community's dogs in the city's parks and public spaces. The police team led by Bath Inspector Steven Mildren and B&NES committed to addressing this through better enforcement and urged all residents to call 101 to report begging (citing that this was a PACT priority) and to call the dog warden service on Council Connect 01225 39 40 41 if they experienced any aggressive dog behaviour. The approach adopted by the police has made a really positive impact and they are now working with a multi agency team to ensure that this positive work continues.

The next PACT meeting takes place at the Guildhall 6.30pm 3rd April 2014, this is a really useful opportunity to discuss and establish local policing priorities. We would urge you to come along and meet the police teams who are responsible for city centre policing. They are a really great team and are very open to listening AND acting on the issues you raise.

In the meantime the Police have urged residents to call 101 if they witness any anti social behaviour. If you don't phone it in, they may not be aware that the problem exists.
