Edward Street One-Way scheme

Plans for the proposed new system are to get further scrutiny. As we are all aware, the road as it is at present is a hazard for Pedestrians and Vehicles alike. Councillor Nicholas Coombes (Lib-Dem, Bathwick) has opposed the plan, saying that buses travelling round Darlington Street will not be able to turn into Great Pulteney Street. The plan is also opposed by First Bus. The decision will now be made later in the year by Councillor Charles Gerrish (Conservative Keynsham North) who has responsibility for traffic in the city. He has stated that he has asked for more information and more research. PERA are all in favour of the one-way system and we shall be letting Cllr. Gerrish have our strongly held views, which we believe, reflect what our members want.



There is a 7 1/2 tonne limit on this street, yet it is frequently being ignored, particularly by Coach operators. We are in the process of bringing this situation in front of the relative authorities.



Gulls

We are continuing with the operation to deal with eggs that will still be laid until the end of August. This is the third and last year for reducing the number of gulls, which has been paid for by money received from the Film Company for 'Vanity Fair'. We have seen a huge reduction in eggs laid on buildings in Great Pulteney Street, and any nests that do appear have the eggs pricked, which prevents development of the eggs. Whilst we realize the Gulls can go elsewhere to breed, there has been a reduction in noise and nuisance levels in the area of this Association, which has been of benefit to us all.

Rubbish

We would ask members not to put rubbish out for collection until after 8 pm the previous day. In our case this would be after 8pm on Sundays. We would also remind members that normal Monday collections of Rubbish now take place on Bank Holidays. As we all have Monday collections, this applies to almost all Bank Holidays. To date, it has been noticed that only a few people seem to realise that this is now the situation.

Some people, not necessarily living within our area, keep placing bags of litter alongside Litter Bins. This inevitably leads to them being attacked by gulls, leaving a nasty mess on the pavement. If you see people doing this, try and persuade them not to, but to take the bags home and leave them out on the appointed day of collection.

We will be arranging a party in the normal way. The venue this year will be different, but will be local. Tickets will cost £5 and will include Snacks and drinks. The Committee is sure that you will find it to be an enjoyable experience. We will give full details in our next Newsletter, due at the end of November.
