The day for collection for our area has been changed to Fridays.

We expect this change to settle down over the next few weeks, so that unsightly rubbish, is not left out for days at a time. However, there are several places in our area, particularly adjacent to bins, where rubbish is put out illegally by various parties. If any member finds that their locality in particular is plagued by this habit they should contact: councilconnect@bathnes.gov.uk and request that one of the Waste Managers comes and opens the bag to determine the miscreant. It is an offence, with a fine payable of £60.

Seagull menace

Residents in Daniel Street have applied to B&NES for a grant towards this year's seagull control measures following successful treatment over previous years. Julian, the pest man, has identified no new nests in Daniel Street this year but signs are that nesting has moved to Bathwick Street.

Grants are available from B&NES of up to 50% of the control measure costs.

Three years ago the residents, led by Derek Alsop of 6 Daniel Street, won their appeal against the music licence granted to the Pulteney Arms and a fairly frosty atmosphere lingered on.

intend to run the pub in a more hands on manner and who hope to welcome PERA members.

Martin known as "Coop" says that he is anxious that the pub gives no cause for complaint by neighbours and the "new broom" is evident from the tidier external area and absence of cigarette butts on the pavement. No attempt is being made to follow the gastropub fashion and the food offered is of the traditional bar menu type. It is hoped members may give their support to this new endeayour.



The contractors, Sir Robert McAlpine, started work on site at the end of March this year where they have already excavated the area to the rear of the building and prepared for the foundations of the new extension.

Work on the extension's basement will continue in the coming months, but it is the imminent arrival of the crane and erection of the scaffolding around the building that will signal that the serious construction and restoration work has begun. Much of the work that will be undertaken between now and the autumn will be out of sight, concentrating on the inside of the existing building – and including the restoration of roof, ceilings and doors, and the major and demanding task of relocating the grand staircase within the building. At the same time the somewhat less glamorous but no less essential installation of pipe-work runs and boiler flues within the building. Before work began - and as was planned - the evergreen Lucombe Oak at the rear of the building was regretfully felled. Lovers of the tree will be pleased to know that the Museum are seasoning its timber and all being

well will use it to create new seats and furniture for the re-opened museum.

Good progress has been made with our appointment of Rhys Brooks, a Conservation Architect, and the help and support of the Bath Preservation Trust. A considerable amount of work has been done, and seemingly endless detailed drawings and documents have been produced. Many conversations have also taken place with B&NES planners. There are now relatively few matters outstanding and we are very hopeful that a full set of documents will be filed for approval by late Summer, with formal consent granted soon after. We are sure that Residents will be impressed with the final design and historical authenticity of the Overthrows and Lanterns.
